Public Hearing & Board Consideration for a Conditional Use Permit from Lee Nicolet and Teresa Nanstad for an Accessory Structure Greater than 1,200 sq. ft. at 1102 Kathryn Drive, Eau Claire: Jared Grande, Eau Claire County Planning & Development Land Use Supervisor introduced the application. The accessory structure proposed is 36' x 42' detached garage which is approximately 1,512 sq. ft. The lot is 2.63 acres with some steep slopes. There are no other outbuildings on the property. Staff does recommend approval with the conditions outlined in their report. Applicant was not present. Town staff did not receive any calls or correspondence regarding the application.

Public Hearing & Board Consideration for a Rezone Request from Patricia Cliff Family Trust, Peter Gartmann, Agent; to Rezone 35 Acres from Agricultural Residential (A2) to Rural Housing (RH) on Talmadge Road, Eau Claire: Parcel 024-1174-02-000:

Matt Michels, Eau Claire County Planning & Development Senior Planner introduced the application. The proposed rezoning of 35 acres from A2 to RH for the purpose of a single family subdivision. This parcel is surround on the north and west by the recently platted Trilogy subdivision. There are some areas of wetlands and would be limited from development. Back in 2016 the Town did official mapping and a 66 ft. right-of-way was dedicated for a future roadway off of Hope Lane. The Future Land Use Map for both the Town and the County show this area as Rural Residential. The proposed concept

shows 11 lots accessed off of Hope Lane and 6 lots fronting on Talmadge Road. The proposal is consistent with the Town and County comprehensive plans.

Admin. Henning received 4 letters opposed to the development and 1 in favor.

Randy Cliff, son of the property owners spoke. His parents owned the property for 35 years. The family decided this was a good time to rezone and develop the property.
