### Dog License 2025 Fee Increase:

Deputy Clerk, Jackie Vold reported that Eau Claire County is increasing their portion of the dog license fee by \$2.00 per dog for 2025. The Town is proposing a \$3 increase to the overall fee (Town's portion would increase by \$1 per dog). The Eau Claire County Humane Association is our law enforcement for animal control; our yearly contract with them has gone up substantially and we do not receive enough revenue to cover the expenditure.

Supv. Tomesh moved TO INCREASE THE DOG LICENSE FEE FOR 2025 TO \$18 FOR ALTERED AND \$28 FOR UNALTERED DOGS. The motion was seconded by Supv. Mueller.

# Resolution 2024-10-17 to Authorize the Town to Exceed the Levy Limit for the Joint Fire Department:

Chrm. Solberg indicated that the Township Fire Department, Inc. has received an answer from the State of Wisconsin after asking for years if they are considered a joint fire department; they are. As a joint fire department, they can increase their levy by CPI plus 2%. All five towns need to pass this ordinance for each individual town to consider raising their own levy. TFD, Inc. has struggled to purchase new trucks and increased funding is vital to a successful fire department. The resolution only authorizes each town to consider increasing their levy limit.

The Board discussed the resolution.

Supv. Mueller moved TO APPROVE RESOLUTION 2024-10-17 TO AUTHORIZE THE TOWN TO EXCEED THE LEVY LIMIT FOR THE JOINT FIRE DEPARTMENT. The motion was seconded by Supv. White.
