A Note from the Town Chair

The Levy and the Limits

What is the Levy? The Levy is the total amount of property taxes collected by and for the Town of Washington. If you review your property tax bill, you'll notice collections for the Town of Washington, Eau Claire County, CVTC, and the school district in which you reside. The sum of these collections for each taxing jurisdiction is considered the Levy.

Years ago, the state established Levy limits at the then-current level. In essence, a municipality cannot raise the Levy unless in specific circumstances: new construction, loan servicing, or by referendum.

The Town of Washington has raised the Levy several times due to new construction. For instance, when we have new construction that increases the Town's assessed value, there is a formula that is used to determine the increase in the total Levy. The Levy increase is offset by the additional tax revenue generated from the new construction. Additionally, we don't have any debt and have never resorted to a referendum to raise the Levy.

In practical terms, what does this mean for you and me? To gain a better understanding, we conducted an unscientific analysis of two properties that have experienced minimal improvements over the past 11 years. Please refer to the table below for details.

Town taxes have remained largely unchanged over the past 11 years due to prudent fiscal management by our staff and previous leadership.

Elections

If you are interested in working as an Election Inspector for the 2026-2027 Election Cycle, fill out and return the poll worker application on our website at https://townofwashington.wi.gov/departments/elections/, and we will contact you in the fall of 2025. Election Inspectors are appointed by the Town Board in December for a 2-year term.

Absentee voting is our largest expense for an election and we want to be fiscally responsible with the Town tax dollars. Please only request an absentee ballot to be mailed if you actually intend to vote that ballot and are unable to come in person.

A public test of our voting equipment is done before every election. The date and time for testing is posted on our website under Notices a couple weeks before an election. Anyone interested in the process is encouraged to attend.

2025 Election

April 1 - Spring Election

Elections are held at the Town Hall from 7:00 a.m. to 8:00 p.m. for all Town of Washington residents.



The Town Board Chairperson and two Town Board Supervisor positions are up for election on April 1, 2025. Offices are for a two-year term. Dates and times for in-person absentee voting are listed on our website.



Dog Licenses

License your dog for 2025 <u>before</u> April 1st. A \$5.00 late fee per dog, will be apply for any payments we received after March 31st.

Open Book & Board of Review If you have just purchased your home in the past year or made any improvements to your home, the Town Assessor

may stop at your property; this would be Gene Johnson, Adam Kremer, or John Garlick from Appraisal Services. Questions should be directed to their office at 715-834-1361.

If you question the assessment of your property, the time for you to do something about it is during Open Book. You do not need an appointment. You just come during the hours it is held to speak with the assessor.

If after reviewing your information at Open Book, you believe your property is not assessed fairly in relation to other Town of Washington properties, you must file a written objection form to be heard by the formal Board of Review. Factual evidence must be presented at the hearing.

Storm Water Pollution Prevention

WHY IS STORMWATER RUNOFF A PROBLEM?

When buildings, parking lots, roads and other hard surfaces are added to the landscape, precipitation no longer soaks into the ground. Water from rain or snow storms, known as stormwater, instead flows over streets, parking lots, roofs, and into a water body or storm drain.


Stormwater runoff is often worsened by human activities, and can contain nitrogen and phosphorus pollutants from fertilizers, pet and yard waste, trash, sediment, and other debris. Because stormwater flows over hard surfaces directly into a water body or storm drain, there is no opportunity for soil and plants to filter out pollutants.

POND MAINTENANCE

When left unmanaged, stormwater ponds can rapidly deteriorate, become aesthetically unpleasing, have poor water quality, and reduce the effectiveness of the wet basin.







Green Waste Facility

The Green Waste Facility at 5710 Jeffers Road provides an environmentally friendly solution for all Eau Claire County residents to dispose of brush, grass clippings, and leaves.

It is operated by the City of Eau Claire.

2025 Season Information:

Typically, the brush site is open mid-April to mid-November; weather dependent.

Well Water Testing Bundles

We get MANY questions about what you should test your well water for. So, we created a few new homeowners bundles to recommend common tests (and save you \$ too!)

Even without a change in color, smell, or taste of the water, many things like bacteria, nitrate, and metals can negatively affect your family's health. Last year at our lab, nearly 1 in 6 drinking water samples from Eau Claire County private wells had bacteria that can make people sick! If YOU have a private well, YEARLY tests for at least bacteria and nitrate are recommended so you can keep your family healthy. Water test results are for your knowledge only. If your water or not. Rest Haven Cemetery

Rest Haven Cemetery is owned and operated by the Town of Washington. For information regarding flowers, wreaths, stone sizes, purchasing spaces, transferring spaces, or scheduling a burial, contact Jackie at 715-834-3257. Spaces are currently available for \$700.

Winter decorations must be removed from the cemetery before April 1, each year. In the Spring, flowers (real or artificial) can be placed in a plant stand beginning May 1 and must be removed no later than October 15 each year. Anything remaining after this date will be disposed of. Items placed in/on the ground or on a shepherd's hook are not allowed and will be removed.



Township Fire Department, Inc. - Station 2

The Township Fire Department wants to alert our residents of the high fire danger due to the mild winter, lack of snow, and very dry conditions. The department tends to be busy during this time and we would like to remind people about safe burning practices. You MUST get a burning permit, which can be found on our website listed below. All the burning regulations can be found on the website as well. Help us by practicing safe burning!

Once again, we will be hosting an Open House at Station 2 on Saturday, June 14, 2025, from 10:00 AM to 2:00 PM along with the Town of Washinton Road Department. Anyone is welcome to come down and see the station. Our trucks will be on display as well as some of the Town equipment. A light lunch will be provided. If you or someone you know is interested in joining the Fire Department, this event is a great opportunity to check out.

For the third year in a row, Station 2 will be hosting an in-person fundraiser breakfast at the Eau Claire County Fair, Saturday, July 26, 2025, from 7:00 to 10:00 AM. Pancakes, sausage, coffee, milk, and bananas will be served. This is a free will donation that assists us with purchasing equipment. We encourage you to stop in to support the Fire Department and then enjoy the rest of the day at the fair.

Here at the Town of Washington Station, we are the busiest of all five stations of the Township Fire Department. Due to our central location as well as Interstate 94 and Highway 53, we run a lot of calls!

We are looking for additional fire fighters to join. We are a paid per call department and could not do with without our

"volunteers". If the fire side of emergency services does not interest you, we also need first responders. Membership of the entire department is at some of the lowest numbers that we have ever seen. Training is provided through the department and in most cases are evening classes at Chippewa Valley Technical College.
